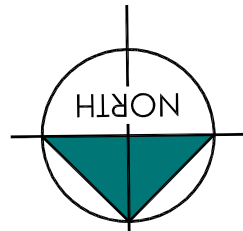


RETAIL A ENLARGED LEASE/SITE PLAN
